This, in turn, has raised the downloads and usage of fitness apps on devices. According to an article which was published in the World Economic Forum in September 2020, the global downloading rate of fitness and health apps increased by 46%. This increased usage rate of fitness apps due to a growing trend of online fitness training is driving the market globally. MARKET RESEARCH

Furthermore, apps that utilize constructs of health behavior theories may not apply all constructs of a particular theory, whether known by the app developer or not, making it impossible to determine the theory's efficacy. Interestingly, more costly apps tend to be of higher quality in terms of usability and include some behavior change techniques.

Fitness app problems

Lack of mobile fitness motivation

Growth of mobile fitness market

A variety of mobile fitness services are emerging due to the needs of modern people who want to exercise comfortably on a schedule that meets their time and place. In fact, the global mobile fitness market is growing rapidly by 13.8% annually, and more than 100,000 related apps have been released. The number of "home training" keyword searches and subscriptions is increasing year by year.

Non-face-to-face training

In the mobile fitness environment, non-face-to-face training is the basic model, so users learn exercise through posts and visual content. This can bring freshness to the user, but it lacks communication and feedback for the continuity of the exercise, and users will lose motivation to learn and give up immediately.

The need for high-quality content

As it is not easy for the users to get motivation, it is necessary to provide a training program with customized recommendations and professional know-how to match the user's needs. However, most mobile fitness apps are not on-demand but are primarily business-oriented services that plan and produce content based on information we can find from anywhere. 4) Application updates


Problem :The applications upgrading span is neglected, leaving the app completely abandoned.
